Effective from December 2024



PREFACE

3DAAA encourages its clubs to host their Sanctioned Events away from club grounds. In doing so, the host club can provide a competition venue which provides equal opportunities for all contestants to compete on an equal footing.

In doing so however, the host club can expose itself to additional risks not encountered at its home grounds. In order to manage this additional risk, the host club should undertake a Risk Assessment of the venue to determine its appropriateness for the event. A copy of the risk assessment must be kept with the signed agreement.

Quite often the issue at the heart of gaining landowner approval is how the tournament will be conducted, the obligations of the landowner and host club and how any risk is to be shared.

Larger venues accustomed to hiring its facilities will usually have some form of approval process and include terms and conditions for its hire. For those small operations that do not, the following Land Use Agreement may provide the basis for an agreement for the host club to access the facility.

The document is in no way a definitive one and particular circumstances will determine its final content. It has been provided however as a guide for the parties to start towards a final agreement.

With a view to continuous improvement, the Committee would appreciate feedback on the content of the document and where modified, a copy of the final document for review.

As part of our insurance agreements, we as an organisation must continue to maintain our policy to ensure the safety of our members and visitors.
